What are Cookies?

A "cookie" is a small text file that is stored on your computer, tablet, or phone when you visit a website. Some cookies are deleted when you close your browser. These are known as session cookies. Others remain on your device until they expire, or you delete them from your cache. These are known as persistent cookies and enable us to remember things about you as a returning visitor.

Types of Cookies

Cookies are used in the following ways on our website:

Туре	Description
Necessary or Session Cookies	These cookies are essential for you to browse the Bank's website and use its features, such as accessing secure areas of the site.
Performance or Analytics Cookies	These cookies collect information about how you use the Bank's website, like which pages you visited, and which links you clicked on. None of this information can be used to identify you. It is all aggregated and, therefore, anonymized. Their sole purpose is to improve website functions.
Functional Cookies	These cookies allow the Bank's website to remember choices you have made in the past, like what language you prefer, what region or what your username and password are so you can automatically log in.
Marketing Cookies	These cookies track your online activity to help the Bank deliver more relevant advertising or to limit how many times you see an ad.

What We Use Cookies For

We use cookies to optimize your user experience when you browse our website. If you register a profile with us, we will use cookies to manage the signup process and general administration and manage your browser session while you are logged in.

Session cookies are always deleted when you log out. Persistent cookies, on the other hand, remain on your device after you log out to help you remember your site preferences and provide a more personalized experience when you return to our website.

We use cookies (and other similar technologies) to:

- Provide products and services that you request and to provide a secure online environment.
- Manage our marketing relationships.
- Improve the performance of our services.
